Before & After Camp Camp begins at 9:30 a.m. and ends at 3:45 p.m. Parents may sign up each Monday for Before & After Camp, which allows campers to arrive as early as 8 a.m. and stay as late as 6 p.m. for an additional fee of \$15 per day. The fee for Before & After Camp is to be paid in full every Friday. The director may decline the continued attendance of any camper whose fee has not been paid the previous week. This charge will apply to all members of the same carpool. Please plan accordingly. These hours and charges also apply to campers who board their horses.

Signing Up A registration fee of \$400 must accompany this completed form. Please make checks payable to Ashford Farm. Camp deposits are non-refundable. Billing will be sent April 10, with the balance due May 1. Camp tuition is fully refundable up to May 1, but because we hire staff and purchase horses, equipment and supplies based on anticipated enrollment, tuition is neither refundable nor pro-rated after May 1.
